



## **RESOLUTION FOR THE REJECTION AND WITHDRAWAL OF THE GRANT APPLICATIONS FOR THE PUBLICATION OF CHILDREN'S AND YOUNG PEOPLE'S ILLUSTRATED BOOKS ABROAD CORRESPONDING TO THE SECOND APPLICATION PROCESS OF 2016**

### **Factual Background**

1. By virtue of the resolution issued by the director of the Institut Ramon Llull on 3 June 2016 (Official Gazette of the Government of Catalonia (DOGC) no. 7145 dated 20 June 2016) the second application process was opened for the awarding of grants (on the basis of competitive tendering) for the publication of children's and young people's picture books abroad in 2016.
2. The applications submitted within the time limit stipulated by the application process are detailed herein.
3. The assessment committee met on 28 October 2016 to examine and nominate the applications submitted.

### **Legal Grounds**

1. The General Grants Act (Law 38/2003 of 17 November) and Royal Decree 887/2006 of 21 July approving the Regulations for said Act.
2. Legislative Decree 3/2002 of 24 December approving the revised text of the Public Finance Act of Catalonia.
3. Government Agreement 110/2014 of 22 July approving the model of regulatory rules for procedures regarding grants awarded on the basis of competitive tendering, as processed by the administration of the Government of Catalonia and the corresponding public sector bodies.
4. Article 90 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 30/1992, of 26 November), states that anybody may withdraw their application, or surrender their rights where legally permitted to do so.
5. Rule 12 of the rules governing the application process for the awarding of grants by the Institut Ramon Llull for activities involving the publication abroad of illustrated children's and young people's literature in 2016, regulates the rejection and withdrawal of the grant applications.

In accordance with the assessment committee's report and rule 12.3 of the rules governing the application process, it is established that it falls upon the examining body to reach a decision regarding the rejection or the withdrawal of the submitted applications,

### **Resolution**

Accordingly, I resolve

- 1 . To declare the withdrawal of the grant applications listed in the Annex I.



2 . To reject the grant application listed in the Annex II.

### **Admissible Appeals**

This resolution does not exhaust the administrative channels for appeal and in accordance with Articles 121 and 122 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October), and with Article 18.1 of the Statutes of the Institut Ramon Llull, an appeal for the matter to be passed to a higher authority may be lodged with the director of the Institut Ramon Llull within a period of one month starting the day after this resolution has been published. The period shall end on the day on which the publication is made.
