

RESOLUTION ON THE REJECTION OF GRANT APPLICATIONS SUBMITTED WITHIN THE APPLICATION PROCESS FOR THE AWARDING OF GRANTS, ON THE BASIS OF COMPETITIVE TENDERING, FOR THE TRANSLATION OF ORIGINAL WORKS OF CATALAN LITERATURE AND PHILOSOPHY IN 2016

Ref. 02/ L0127 U10 N-2T_1C_TRD_2016 REJECTIONS

Factual Background

1. By virtue of the resolution issued by the director of the Institut Ramon Llull on 16 March 2016 (Official Gazette of the Government of Catalonia (DOGC) no. 7082 of 18 March 2016), the application process was opened for the awarding of grants, on the basis of open and competitive tendering, for the translation of original works of Catalan literature and philosophy in 2016.

2. The applications submitted within the time limit stipulated by the application process are detailed herein.

3. The assessment committee met on 12 July 2016 to analyse and evaluate the submitted applications.

Legal Grounds

1. The General Grants Act (Law 38/2003 of 17 November) and Royal Decree 887/2006 of 21 July approving the Regulations for said Act.

2. Legislative Decree 3/2002 of 24 December approving the revised text of the Public Finance Act of Catalonia.

3. Government Agreement 110/2014 of 22 July approving the model of regulatory rules for procedures regarding grants awarded on the basis of competitive tendering, as processed by the administration of the Government of Catalonia and the corresponding public sector bodies. (DOGC no. 6671 of 24 July 2014).

4. Rule 11, which governs the awarding of grants by the Institut Ramon Llull for the translation of original works of Catalan literature and philosophy for 2016, provides for the rejection and withdrawal of applications.

In accordance with rule 11.3 of the rules governing the application process, which stipulates that the examining body is responsible for reaching a decision with regard to the rejection and withdrawal of any of the applications submitted,

To reject the grant application specified in Annex.
