

RESOLUTION DECIDING ON REJECTED AND WITHDRAWN APPLICATIONS FROM THE THIRD CALL FOR THE AWARDING OF GRANTS ON A COMPETITIVE BASIS TO PUBLISH ILLUSTRATED WORKS ABROAD

Ref. 02/L0125 U10_RESOL_INADM_DESIST_OIL_3aC

Acts

1. By resolution of the Director of the Institut Ramon Llull Consortium (hereinafter, the "Institut Ramon Llull") dated 19 July 2024 (DOGC no. 9213, of 26 July 2024) concerning the third call 2024 for the awarding of grants on a competitive basis to publish illustrated works abroad (ref. BDNS 776188).
2. By resolution of the Director of the Institut Ramon Llull of 29 November 2024 (DOGC no. 9304, of 4 December 2024) amending the budget allocation of the third call 2024 for the awarding of grants on a competitive basis to publish illustrated works abroad (ref. BDNS 776188).
3. Applications submitted by the deadline specified in the call are included in the file.
4. The evaluation committee met on 21 November 2024 to analyse and evaluate the applications submitted.

Legal bases

1. Law 38/2003, of 17 November, on General Subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulations of Law 38/2003, of 17 November, on General Subsidies.
2. Legislative Decree 3/2002, of 24 December, approving the revised text of the Public Finance Act of Catalonia.
3. Government Agreement GOV/85/2016, of 28 June, approving the amendment of the standard form of regulatory bases approved by Agreement GOV/110/2014, of 22 July, approving the standard form of regulatory bases for the procedures of the awarding of grants on a competitive basis, processed by the Administration of the Generalitat (Government of Catalonia) and its public sector, and approving the full text.
4. Resolution of 17 January 2024 (DOGC no. 9085, of 23 January 2024) announcing an agreement by the Board of Directors on 21 December 2023 amending the terms and conditions that must govern the awarding of grants to publish illustrated works abroad.
5. Articles 21, 94.1 and 94.4 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administration.
6. Section 12 of the terms and conditions governs the awarding of grants by the Institut Ramon Llull for publishing illustrated works abroad and regulates rejected and withdrawn applications.
7. Point 12.3 of the terms and conditions states that it is up to the examining body to decide on rejected and withdrawn applications that are submitted.
8. Point 12.4 states that, without prejudice to the withdrawal provided for in point 11.4, any applicant may withdraw their grant application in writing before the grant is awarded and that the examining body must accept this withdrawal.



Resolution

- Reject the grant applications listed in the Annex I.
- Accept the withdrawal and declare the grant procedure closed for the applications listed in Annex II.

Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administration and with Article 19 of the statutes of the Institut Ramon Llull, may be appealed and any such appeals must be lodged with the President of the Institut Ramon Llull's Board of Directors within one month of the day following the publication of this resolution. The one-month term ends on the same date the resolution was published.

Point 1.1 states that the work for which the grant is requested must be contractually acquired in one of the following three ways: work commissioned by a foreign publisher, transfer of rights to a work already published and international co-publication.

In the case of a work commissioned by a foreign publisher to an illustrator domiciled in Catalonia or the Balearic Islands, the work must be published and distributed abroad, and its publication must be the result of a contract between the foreign publisher of the original edition and the illustrator or his/her representative.

In this case, Fulgencio Pimentel Sociedad Limitada is domiciled in Oyón (Spain) and is therefore not a foreign publisher.
