

# PROPOSED PROVISIONAL DECISION ON THE AWARDING OF GRANTS, ON A COMPETITIVE BASIS, FOR THE FIRST CALL FOR ACTIVITIES AIMED AT PROMOTING CATALAN AND ARANESE LITERATURE ABROAD

Ref. 02/ L0124 U10 PROMOCIÓ RES. PROVISIONAL (1a C)

#### **Facts**

- 1. By decision of the Director of the Consorci Institut Ramon Llull (hereinafter, the Institut Ramon Llull), of 29 January 2025 (DOGC no. 9345, of 6 February 2025), the first call awarding the grants, on a competitive basis, for activities aimed at promoting Catalan and Aranese literature abroad.
- 2. Applications submitted within the deadline established in the reference call are included in the dossier.
- 3. On 5 June 2025, the assessment committee meets to analyse and assess the applications submitted.

# Legal grounds

- 1. Law 38/2003, of 17 November, on General Subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November, on General Subsidies.
- 2. Legislative Decree 3/2002, of 24 December, approving the Revised Text of the Law on Public Finances of Catalonia.
- 3. The Government Agreement GOV/85/2016, of 28 June, approving the modification of the standard model of guidelines approved by Agreement GOV/110/2014, of 22 July, approving the standard model of guidelines of the procedures for awarding grants under a competitive basis, processed by the Administration of the Generalitat de Catalunya and its public sector, and approves the full text.
- 4. The Decision dated 22 January 2025 (DOGC no. 9337, of 27 January 2025) publicising the Agreement of the Board of Directors dated 16 January 2025 amending the guidelines governing the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad.
- 5. Rule 10 of the guidelines governing the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad regulates the procedure for awarding grants.
- 6. Rule 10.3 of the aforementioned guidelines establishes that applications are analysed by an assessment committee whose composition is determined in the guidelines themselves. The members of the evaluation committee are appointed by decision of the Director of the Consorci Institut Ramon Llull.
- 7. Rule 10.5 of these guidelines establishes that it is the responsibility of the examining body to formulate the proposal for an interim decision on awarding the grants.



#### Decision

Therefore, I decide,

- 1. To propose the applicants listed in the annex as recipients of the grants for the amounts and purpose detailed therein.
- 2. To establish that applicants proposed as recipients of grants have 10 working days, counting from the day following the publication of this decision, to present allegations or withdraw their application.
- 3. To require the applicants proposed as recipients in the annex to submit, within 10 working days from the day following the publication of this decision, the documentation listed in rule 11.5 of the guidelines previously provided that has undergone any modification, indicating that failure to submit entails the assumption of the documentation provided as true.
