

## RESOLUTION RESOLVING TO ACCEPT WITHDRAWAL OR REJECT APPLICATIONS FOR THE SECOND CALL FOR COMPETITIVE GRANTS FOR ACTIVITIES AIMED AT PROMOTING CATALAN AND ARANESE LITERATURE ABROAD

### RECITALS

1. Resolution of the director of Consorci de l'Institut Ramon Llull (hereinafter Institut Ramon Llull), dated 4 June 2025 (DOGC number 9431, of 11 June 2025) opened the second call to award grants, on a competitive basis, for activities aimed at promoting Catalan and Aranese literature abroad.
2. The applications submitted by the deadline established in the call are listed in the file.
3. On 27 October 2025, the assessment committee met to analyse and assess the applications submitted.

### Legal basis

1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).
2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia.
3. Resolution dated 22 January 2025 (DOGC number 9337, of 27 January 2025) announcing the agreements of the Board of Directors dated 16 January 2025 modifying the guidelines governing the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad.
4. Articles 21, 94.1 and 94.4 of Law 39/2015, of 1 October, on Common Administrative procedure of public administrations.
5. Point 12 of the guidelines governing the awarding of grants by Institut Ramon Llull for activities aimed at promoting Catalan and Aranese literature abroad deals with rejection and withdrawal of applications.
6. Point 12.3 of the guidelines governing this call provides that it is the task of the examining body to issue resolutions rejecting or withdrawing applications.
7. Point 12.4 of the aforementioned rules provides, without prejudice to the withdrawal established in point 11.4, that any applicant may withdraw their grant application in writing before the grants are awarded and the examining body must accept it.

Now, therefore, be it resolved that:

1. The grant applications listed in Annex I be rejected.
2. The grant applications listed in Annex II be considered withdrawn.

### **Lawful appeals**

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, and article 19 of the Institut Ramon Llull bylaws, may be appealed and any such appeals must be lodged with the Institut Ramon Llull management within one month of the day following notification of this resolution.

One of the lines point 1 establishes is events promoting Catalan and Aranese literature that take place outside Catalan- and Aranese-speaking areas: international literary festivals, international book fairs open to the general public, book launches and promotional campaigns for translated works. However, it also establishes that activities in the academic sphere are not eligible.

The activity to which this application pertains is a theatre performance and conference on theatre to be held at a university theatre in the city of Venice.
