

PROVISIONAL RESOLUTION PROPOSAL OF THE CALL FOR THE AWARDING OF GRANTS ON A COMPETITIVE BASIS FOR INTERNATIONAL RESIDENCY PROJECTS IN THE FIELDS OF THE VISUAL ARTS, PERFORMING ARTS, FILM, MUSIC, DESIGN AND ARCHITECTURE

Acts

1. By resolution of the Director of the Institut Ramon Llull Consortium (hereinafter, the “Institut Ramon Llull”) dated 16 May 2024 (DOGC no. 9170, of 27 May 2024) concerning the call for the awarding of grants on a competitive basis for international residency projects in the fields of the visual arts, performing arts, film, music, design and architecture (ref. BDNS 761829).
2. Applications submitted by the deadline specified in the call are included in the file.
3. The evaluation committee met on 16 September 2024 to analyse and evaluate the applications submitted.

Legal bases

1. Law 38/2003, of 17 November, on General Subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulations of Law 38/2003, of 17 November, on General Subsidies.
2. Legislative Decree 3/2002, of 24 December, approving the revised text of the Public Finance Act of Catalonia.
3. Government Agreement GOV/85/2016, of 28 June, approving the amendment of the standard form of regulatory bases approved by Agreement GOV/110/2014, of 22 July, approving the standard form of regulatory bases for the procedures of the awarding of grants on a competitive basis, processed by the Administration of the Generalitat (Government of Catalonia) and its public sector, and approving the full text.
4. Resolution of 28 June 2023 (DOGC no. 8949, of 3 July 2024) by which publicity is given to the Agreement of the Board of Directors dated 16 June 2024, which modifies the terms and conditions that must govern the awarding of grants for international residency projects in the fields of the visual arts, performing arts, film, music, design and architecture.
5. Section 10 of the terms and conditions governing the Institut Ramon Llull’s awarding of grants for international residency projects in the fields of the visual arts, performing arts, film, music, design and architecture.
6. Point 10.3 of the aforementioned terms and conditions states that applications are to be analysed by an evaluation committee appointed in the grant call that is composed of external experts.
7. Point 10.4 of these terms and conditions states that it is up to the examining body to formulate the proposal for a provisional resolution on the awarding of grants.

Resolution

I therefore hereby resolve to

1. Propose that the applicants listed in the Annex are beneficiaries of the grants for the amounts and purposes set out therein.



2. State that the applicants proposed as beneficiaries of the grants have 10 working days from the day following the publication of this resolution in which to submit any objections or to withdraw their applications.
3. Request that the applicants proposed as beneficiaries in the Annex submit within 10 working days from the day following the publication of this resolution the previously submitted documentation relating to point 11.5 that has had any changes made to it and to inform them that failure to do so entails the acceptance of the documentation submitted as true.
4. Request, where applicable, that the applicants proposed as beneficiaries in the Annex submit the necessary documentation within 10 working days from the day following the publication of this resolution.
5. State that failure to submit the required documentation within 10 working days from the day following the publication of this resolution shall entail withdrawal of the application.
