

RESOLUTION RESOLVING ON WITHDRAWN APPLICATIONS FROM THE CALL FOR THE AWARDING OF GRANTS ON A COMPETITIVE BASIS FOR THE INDIVIDUAL INTERNATIONAL MOBILITY OF ARTISTS IN THE FIELDS OF AUDIOVISUAL PRODUCTIONS, PERFORMING ARTS, MUSIC, VISUAL ARTS, DESIGN AND ARCHITECTURE

Acts

1. Resolution of the director of the Consortium of the Institut Ramon Llull dated 24 May 2024 (DOGC number 9175 of 3 June 2024) opened the call for competitive grants for individual international mobility of artists in the fields of audiovisual productions, performing arts, music, visual arts, design and architecture (ref. BDNS 763315).

2. The applications submitted by the deadline established in the call are listed in the file.

3. On 10 September 2024, the assessment committee met to analyse and assess the applications submitted.

4. On 15 October 2024, the resolution resolving the withdrawals and non-admissions of the grant applications corresponding to this call and the provisional resolution proposal for the awarding of grants were published in the virtual office of the Consortium of the Institut Ramon Llull and on the notice board at the headquarters in Barcelona of the Consortium of the Institut Ramon Llull.

Legal basis

1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).

2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of the Public Finance Act of Catalonia.

3. Agreement GOV/85/2016 of 28 June, which approves the modification of the type of regulatory basis approved by the Agreement GOV/110/2014 of 22 July, by which the types of regulatory bases of the procedures for the granting of subsidies under competitive competition, processed by the Administration of the Catalan Government and its public sector, are approved (DOGC number 7152 of 30/06/2016).

4. Resolution dated 28 June 2023 (DOGC number 8949, of 3 July 2023) announcing the agreements of the Board of Directors dated 16 June 2023 modifying the guidelines governing the awarding of grants for individual international mobility of artists in the fields of audiovisual productions, performing arts, music, visual arts, design and architecture.

5. Article 94.1 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, provides that all interested parties may withdraw their application or, when not prohibited by law, waive their rights.

6. Articles 21, 93, 94.1 and 94.4 of Law 39/2015, of 1 October, on Common Administrative procedure of public administrations.

7. Point 10.3 establishes that applications are examined by an assessment committee and establishes its composition. It also establishes that the members of the assessment committee are appointed by resolution of the person holding the Management of the Institut Ramon Llull.



8. Point 12 of the guidelines covers rejection and withdrawal of applications.

9. Point 12.3 of the guidelines governing this call provides that it is the task of the examining body to issue resolutions rejecting or withdrawing applications.

10. Point 12.4 provides, without prejudice to the withdrawal established in point 11.4, that any applicant may withdraw their grant application in writing before the grants are awarded and the examining body must accept it.

Resolution

Now, therefore, be it resolved that:

- The withdrawal of the grant applications listed in Annex shall be accepted and the proceedings declared closed.

Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, may be appealed and any such appeals must be lodged with the Director of the Consortium of the Institut Ramon Llull within one month of the day following notification of this resolution. The one-month term ends on the day of notification.
