RESOLUTION FOR THE AWARDING OF GRANTS ON A COMPETITIVE BASIS OF THE THIRD 2024 CALL FOR THE PUBLISHING PRODUCTION OF TRANSLATIONS OF ORIGINAL WORKS OF LITERATURE IN CATALAN AND OCCITAN (IN ITS ARANESE VARIANT)

Acts

1. By resolution of the Director of the Institut Ramon Llull Consortium (hereinafter, the "Institut Ramon Llull") dated 26 July 2024 (DOGC no. 9217, of 1 August 2024) concerning the third call 2024 for the awarding of grants on a competitive basis for the publishing production of translations of original works of literature in Catalan and Occitan (in its Aranese variant) (ref. BDNS 77486).

2. Applications submitted by the deadline specified in the call are included in the file.

4. The evaluation committee met on 15 November 2024 to analyse and evaluate the applications submitted.

5. On 4 December 2024, the examining body issued a provisional resolution proposal for the awarding of grants, based on the recommendations of the assessment committee.

6. On 20 December 2024 the examining body issued a resolution proposal for the awarding of grants, based on the assessment committee proposal.

Legal bases

1. Law 38/2003, of 17 November, on General Subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulations of Law 38/2003, of 17 November, on General Subsidies.

2. Legislative Decree 3/2002, of 24 December, approving the revised text of the Public Finance Act of Catalonia.

3. Government Agreement GOV/85/2016, of 28 June, approving the amendment of the standard form of regulatory bases approved by Agreement GOV/110/2014, of 22 July, approving the standard form of regulatory bases for the procedures of the awarding of grants on a competitive basis, processed by the Administration of the Generalitat (Government of Catalonia) and its public sector, and approving the full text.

4. Resolution of 17 January 2024 (DOGC no. 9085, of 23 January 2024) announcing an agreement by the Board of Directors on 21 December 2023 amending the terms and conditions that must govern the awarding of grants for the publishing production of translations of original works of literature in Catalan and Occitan (in its Aranese variant).

5. Section 10 of the terms and conditions governing the Institut Ramon Llull's awarding of grants for the publishing production of translations of original works of literature in Catalan and Occitan (in its Aranese variant) regulates the grant award procedure.

6. Point 10.1 of said guidelines establishes that the procedure for the granting of subsides is being processed under competitive competition.

7. Point 10.3 of the aforementioned terms and conditions states that applications are to be analysed by an evaluation committee appointed in the grant call that is composed of external experts. The members of the evaluation committee are appointed by resolution of the person appointed as Director of the Institut Ramon Llull Consortium.

8. Point 1.2 states that grants awarded in accordance with these guidelines are considered de minimis aid, governed by Commission Regulation (EU) 2023/2831 of 13 December 2023 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (DOUE L2023, de 15.12.2023).

9. Point 12.2 establishes that the resolution will expressly state that the award is a de minimis grant.

10. Point 13.1 establishes that the person holding the Management position of the Institut Ramon Llull will resolve within a maximum period of six months from the date of publication of the call.

11. Institut Ramon Llull has earmarked funds in this year's budget to cover the grants awarded herein.

Article 13.2 e) of the Institut Ramon Llull bylaws grants the person holding the Management position the power to resolve issues of grants.

Resolution

Now, therefore, be it resolved that:

1. Grants be awarded for the purpose and amounts to the entities listed in the Annex.

2. Payment of 100% shall be processed once all the supporting documents for the grant-funded activity and the expenditure incurred have been submitted, as per the terms in the point 16 of the guidelines governing this call.

3. These grants shall be considered de minimis grants, governed by Commission Regulation (EU) 2023/2831 of 13 December 2023 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (DOUE L2023, de 15.12.2023).

4. The recipients of the grants must undertake to provide any information requested regarding the grant awarded, always, and submit to any reviews or monitoring that Institut Ramon Llull or other competent bodies deem necessary.



Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, may be appealed and any such appeals must be lodged with the President of the Institut Ramon Llull Board of Directors within one month of the day following publication of this resolution. The one-month term ends on the same date the resolution was published.
