

RESOLUTION FOR THE REJECTION AND INELIGIBILITY OF GRANT APPLICATIONS FOR THE PUBLICATION OF CHILDREN'S AND YOUNG PEOPLE'S ILLUSTRATED BOOKS ABROAD CORRESPONDING TO THE SECOND APPLICATION PROCESS FOR 2018

Factual Background

1. By virtue of the resolution issued by the Director of the Institut Ramon Llull on 18 May 2018 (Official Gazette of the Government of Catalonia (DOGC) no. 7650 dated 26 June 2018) the second application process was opened for the awarding of grants (on the basis of competitive tendering) for the publication of children's and young people's illustrated books abroad in 2018.

2. The applications submitted within the time limit stipulated in the aforementioned resolution are held on file.

3. The assessment committee met on 15 Novembre 2018 to examine and nominate the applications submitted.

Legal Grounds

1. The General Grants Act (Law 38/2003 of 17 November) and Royal Decree 887/2006 of 21 July approving the Regulations for said Act.

2. Legislative Decree 3/2002 of 24 December approving the revised text of the Public Finance Act of Catalonia.

3. Government Agreement 85/2016 of 28 June approving the modification of the model regulatory rules approved by Government Agreement 110/2014 of 22 July, which approves the model of regulatory rules for procedures regarding grants awarded on the basis of competitive tendering, as processed by the administration of the Government of Catalonia and the corresponding public sector bodies, and approves the agreement's full text.

4. Article 21 of Law 39/2015 of 1 October on the common administrative procedure for public administrations establishes that in cases where rights are renounced, where the procedure has expired or where applications are rejected, or where the reason for the procedure no longer exists, the resolution will declare the circumstances of each case and specify the facts and the applicable regulations.

5. Rule 12, which governs the awarding of grants by the Institut Ramon Llull for the publication of children's and young people's illustrated books abroad in 2017, regulates applications'ineligibility and rejection.

In accordance with the assessment committee's report and rule 12.3 of the rules governing the application process, which establishes that it falls upon the examining body to reach a decision regarding applications'ineligibility and rejection.



Resolution

Accordingly, I resolve

- 1. To accept the rejection and declare the grant applications procedure described in Annex I closed.
- 2. That the grant applications described in Annex II have been declared ineligible.

Admissible Appeals

This resolution does not exhaust the administrative channels for appeal and in accordance with Articles 121 and 122 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October), and with Article 19 of the Statutes of the Institut Ramon Llull, an appeal for the matter to be passed to a higher authority may be lodged with the Director of the Institut Ramon Llull within a period of one month, starting the day after this resolution has been published. The one-month period shall end on the same day on which publication takes place.

The committee proposes that the application presented by Kalandraka Editora, SL for illustrations by Zuzanna Celej for the publication in Spanish of *El Secreto del Abuelo Oso*, by Pedro Mañas, be rejected, given that it failed to comply with one of the requirements of point 1 of the guidelines regulating this call for applications

Point 1.1 of the guidelines established that the works for which grant applications are submitted must be published in languages other than Catalan, Aranese and Spanish. The applicant had applied for a grant to publish the work in Spanish.

The committee proposes that the application presented by Ivana Maria Tavares Jinkings for illustrations of the publication in Portuguese of the work *El ratón y la montaña* written and illustrated by Laia Domènech, be rejected, given that it failed to comply with one of the requirements of point 1 of the guidelines regulating this call for applications Point 1.1 of the guidelines establishes that works for which grant applications are submitted must not have been published in the language for which the grant is requested prior to the date on which grants are formally attributed. Ivana Maria Tavares published the work in November 2018.
