

RESOLUTION OF THE APPLICATION PROCESS FOR THE AWARDING OF GRANTS FOR THE PUBLICATION OF CHILDREN'S AND YOUNG PEOPLE'S ILLUSTRATED BOOKS ABROAD CORRESPONDING TO THE THIRD APPLICATION PROCESS OF 2019.

Recitals

- 1. By resolution of the director of Consortium of the Institut Ramon Llull (hereinafter, Institut Ramon Llull), dated 14 June 2019 (DOGC number 7907 of 1 July 2019) and its modification dated 20 November 2019 (DOGC no. 8015 of 3 December 2019), the third 2019 call for grant applications was opened, on a competitive basis, to publish illustrated works of children's and young-adult literature in foreign markets.
- 2. On 14 November 2019, the assessment committee met to study and propose the applications submitted.
- 3. On 3 December 2019, the examining body formulated a motion for a provisional resolution on the award of the grants, in accordance with the assessment committee's motion.
- 4. On 20 December 2019, the examining body formulated a proposal for a definitive resolution on the award of the grants, in accordance with the assessment committee's motion.

Legal basis

- 1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).
- 2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia.
- 3. Agreement GOV/85/2016 of 28 June, which approves the modification of the type of regulatory basis approved by the Agreement GOV/110/2014 of 22 July, by which the types of regulatory bases of the procedures for the granting of subsidies under competitive competition, processed by the Administration of the Catalan Government and its public sector, are approved.
- 4. Rules 1.2 and 13.2 of the rules governing the Institut Ramon Llull's application process for the awarding of grants for the publication of children's and young people's illustrated books abroad.
- 5. The Institut Ramon Llull has adequate and sufficient funds in its current budget.

Article 13.2(e) of the Statutes of the Institut Ramon Llull empowers the director of the Institut Ramon Llull to award grants.

RESOLUTION

Accordingly, I resolve

1- To award grants for the stipulated sums and purposes to the applicants specified in the Annex.



- 2- To stipulate that 100% of the sum of each grant shall be paid once the supporting documentation for the activity in question has been submitted, along with supporting documentation for the expenses incurred, in accordance with the terms stipulated in rule 16 of the grant-application process. In any case, payment will be made the year following that in which the application process takes place.
- 3- To establish that these grants are considered *de minimis* aid, governed by Commission Regulation (EU) 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to *de minimis* aid (OJEU L352 of 24/12/2013).
- 4- To establish that the beneficiaries agree to provide, whenever requested, any information that may be requested of them in relation to the grant awarded and to undergo any verification procedures that the Institut Ramon Llull, or any other competent body, deem necessary.

Admissible Appeals

This resolution does not exhaust the administrative channels for appeal and, in accordance with Articles 121 and 122 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October), an appeal for the matter to be passed to a higher authority may be lodged with the Chairman of the Management Board of the Institut Ramon Llull within a period of one month following the publication of this resolution. The one month period is settled on the same day as the date of the publication.
