

RESOLUTION ON THE APPLICATION PROCESS FOR THE AWARDING OF GRANTS FOR ACTIVITIES INVOLVING THE PROMOTION OF CATALAN AND ARANESE LITERATURE ABROAD, CORRESPONDING TO THE SECOND APPLICATION PROCESS OF 2019.

Ref. 02/ L0124 U10 N-2aC_2019_ RES. DEF

Recitals

1. By resolution of the director of Institut Ramon Llull (hereinafter, Institut Ramon Llull), dated 29 May 2019 (DOGC number 7895 of 12 June 2019), the second 2019 call for grant applications was opened, on a competitive basis, for the awarding of grants by the Llull for activities aimed at promoting Catalan and Aranese literature abroad.

2. On 12 November 2019, the assessment committee met to analyse and assess the applications submitted.

3. On 3 December 2019, the examining body formulated a motion for a provisional resolution on the awarding of the grants, in accordance with the assessment committee's proposal.

4. On 20 December 2019, the examining body drew up a proposed resolution on the awarding of the grants, in accordance with the assessment committee's proposal.

Legal basis

1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).

2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia.

3. Agreement GOV/85/2016 of 28 June, which approves the modification of the type of regulatory basis approved by the Agreement GOV/110/2014 of 22 July, by which the types of regulatory bases of the procedures for the granting of subsidies under competitive competition, processed by the Administration of the Catalan Government and its public sector, are approved.

4. The rules 1.2 and 13.2 of the rules governing the application process for the awarding of grants by the Institut Ramon Llull for activities involving the promotion of Catalan and Aranese literature abroad.

5. The Institut Ramon Llull has adequate and sufficient funds in its current budget.

Article 13.2(e) of the Statutes of the Institut Ramon Llull empowers the Director of the Institut Ramon Llull to award grants.



Resolution

Accordingly, I resolve:

1. To award grants to the applicants listed in the annex, for the amounts and purposes stipulated therein.

2. To stipulate that the Institut Ramon Llull will process payment of 100% of the grant awarded once the grantfunded activity has concluded and the supporting documents specified in Rule 16 have been submitted.

3. To stipulate that these grants are considered *de minimis* aid, governed by Commission Regulation (EU) 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty of the Functioning of the European Union to *de minimis* aid (OJEU L352 of 24/12/2013).

4. To stipulate that the beneficiaries undertake to provide, whenever requested, any information that may be requested from them by the Institut Ramon Llull regarding the grant awarded, and to undergo any verification and monitoring procedures that the Institut Ramon Llull or other competent bodies deem necessary.

Admissible appeals

This resolution does not exhaust the administrative channels for appeal and, in accordance with Articles 121 and 122 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October), an appeal for the matter to be passed to a higher authority may be lodged with the Chairman of the Management Board of the Institut Ramon Llull within a period of one month following the publication of this resolution. The one month period is settled on the same day as the date of the publication.
