RECITALS

1. By resolution of the director of the Consortium of the Institut Ramon Llull (hereinafter, Institut Ramon Llull), dated 29 May 2019 (DOGC number 7895 of 12 June 2019), the second 2019 call for grant applications was opened, on a competitive basis, for the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad.

2. By resolution of the director of Institut Ramon Llull, dated 20 December 2019, the second 2019 call for grant applications for the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad is resolved.

3. On 22 January 2020, an arithmetical error is detected in some of the amounts awarded for this resolution as well as in those stated in the Committee's evaluation report, in the provisional resolution and in the proposal for the definitive resolution, and thus it is proposed to amend it.

LEGAL BASIS

1. Article 109 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October) provides that Public Administrations may, at any time, rectify, at their own initiative or at the request of the interested parties, any material, de facto or arithmetical errors in their acts.

2. Article 13.2(e) of the Statutes of the Institut Ramon Llull empowers the Director of the Institut Ramon Llull to award grants.
