

RESOLUTION ON THE EARLY APPLICATION PROCESS FOR THE AWARDING OF GRANTS, ON THE BASIS OF COMPETITIVE TENDERING, FOR THE PUBLICATION OF ILLUSTRATED CHILDREN'S AND YOUNG PEOPLE'S LITERATURE ABROAD IN 2017

## **Factual Background**

- 1. By means of the resolution issued by the Director of the Institut Ramon Llull on 12 September 2016 (Official Gazette of the Government of Catalonia (DOGC) no. 7209 dated 20 September 2016) the early application process was opened for the awarding of grants (on the basis of competitive tendering) for the publication of children's and young people's illustrated books abroad in 2017.
- 2. The assessment committee met on 11 January 2017 to examine and nominate the applications submitted.
- 3. On 23 January 2017, the examining body formulated a motion for a provisional resolution on the award of the grants, in accordance with the assessment committee's motion.
- 4. On 2 March 2017, the examining body formulated a proposal for a definitive resolution on the award of the grants, in accordance with the assessment committee's motion.

## **Legal Grounds**

- 1. The General Grants Act (Law 38/2003 of 17 November) and Royal Decree 887/2006 of 21 July approving the Regulations for said Act.
- 2. Legislative Decree 3/2002 of 24 December approving the revised text of the Public Finance Act of Catalonia.
- 3. Government Agreement 85/2016 of 28 June approving the modification of the model regulatory rules approved by Government Agreement 110/2014 of 22 July, which approves the model of regulatory rules for procedures regarding grants awarded on the basis of competitive tendering, as processed by the administration of the Government of Catalonia and the corresponding public sector bodies.
- 4. Rules 1.2 and 13.2 of the rules governing the early application process for the awarding of grants by the Institut Ramon Llull for the publication abroad of illustrated children's and young people's literature in 2017.
- 5. The Institut Ramon Llull has adequate and sufficient funds in its current budget.

Article 13.2(e) of the Statutes of the Institut Ramon Llull empowers the director of the Institut Ramon Llull to award grants.

#### Resolution

Accordingly I resolve,

1- To award grants for the stipulated sums and purposes to the applicants specified in the Appendix.



- 2- To stipulate that 100% of the sum of each grant shall be paid once the supporting documentation for the activity in question has been submitted, along with supporting documentation for the expenses incurred, in accordance with the terms stipulated in rule 16 of the grant-application process. In any case, payment will be made the year following that in which the application process takes place.
- 3- To establish that these grants are considered *de minimis* aid, governed by Commission Regulation (EU) 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to *de minimis* aid (OJEU L352 of 24/12/2013).
- 4- To establish that the beneficiaries agree to provide, whenever requested, any information that may be requested of them in relation to the grant awarded and to undergo any verification procedures that the Institut Ramon Llull, or any other competent body, deem necessary.

# **Admissible Appeals**

This resolution does not exhaust the administrative channels for appeal and, in accordance with Articles 121 and 122 of the Legal Framework for Public Administrations and Common Administrative Procedure Act (Law 39/2015 of 1 October), an appeal for the matter to be passed to a higher authority may be lodged with the Chairman of the Management Board of the Institut Ramon Llull within a period of one month following the publication of this resolution. The one month period is settled on the same day as the date of the publication.
