

# PROPOSED PROVISIONAL DECISION ON THE CALL FOR APPLICATIONS FOR THE AWARDING OF GRANTS, ON A COMPETITIVE BASIS, FOR THE INTERNATIONAL PROGRAMMING OF CATALAN ARTISTIC CREATION IN THE FIELD OF THE VISUAL ARTS, DESIGN AND ARCHITECTURE

Ref. 02/ L0198 U10 N- PROP\_RESOL\_PROV

#### **Background facts**

1. By decision of the Director of the Consortium of the Institut Ramon Llull of 29 January 2024 (DOGC [Official Journal of the Government of Catalonia (*Diari Oficial de la Generalitat de Catalunya*)] number 9093, of 2 February 2024), a call for applications is hereby opened for the awarding of grants, on a competitive basis, for the international programming of Catalan artistic creation in the field of the visual arts, design and architecture (ref. BDNS 741630).

2. Applications submitted by the deadline established in the aforementioned call for applications are included in the dossier.

3. On 6 May 2024, the assessment committee met to analyse and assess the applications submitted.

#### Legal bases

1. Law 38/2003, of 17 November, on general provisions for grants and subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November, on general provisions for grants and subsidies.

2. Legislative Decree 3/2002 of 24 December, approving the Consolidated Text of the Catalan Public Finance Act.

3. Agreement GOV/85/2016, of 28 June, approving the amendment of the standard template for governing terms and conditions approved by Agreement GOV/110/2014, of 22 July, approving the standard template for terms and conditions governing procedures for the awarding of grants, on a competitive basis, processed by the Administration of the Government of Catalonia and its public sector, and approving the full text.

4. The decision dated 17 January 2024 (DOGC [Official Journal of the Government of Catalonia (*Diari Oficial de la Generalitat de Catalunya*)] no. 9085, 23 January 2024) publicising the Decision of the Board of Directors dated 21 December 2023 approving the terms and conditions governing the awarding of grants for the international programming of Catalan artistic creation in the field of visual arts, design and architecture.

5. Clause 10 of the terms and conditions governing the call for applications for the awarding of grants from the Consortium of the Institut Ramon Llull for the international programming of Catalan artistic creation in the field of visual arts, design and architecture governs the grant award procedure.

6. Clause 10.3 of the aforementioned terms and conditions establishes that applications are analysed by an assessment committee, appointed in the call for applications, which shall include external experts.

7. Clause 10.4 of these terms and conditions establishes that it is the responsibility of the examining body to formulate the proposal for the provisional decision on the awarding of grants.

## Decision

I therefore decide:

1. To propose the applicants listed in the annex as beneficiaries of the grants for the amounts and for the purposes set forth therein.

2. To establish that the applicants proposed as beneficiaries of grants have 10 working days from the day following the publication of this decision to submit representations or abandon their application.

3. To notify the applicants proposed as beneficiaries in Annex I that they must submit, within 10 working days of the day following the publication of this resolution, any previously provided documentation listed in Clause 11.5 that has undergone amendment, advising them that failure to do so entails the assumption that the documentation provided as true.

4. To notify, where appropriate, the applicants proposed as beneficiaries in Annex I that they must submit the required documentation within 10 working days of the day following the publication of this decision.

5. To establish that failure to submit the required documentation within 10 working days of the day following the publication of this decision shall result in the abandonment of the application.
