

RESOLUTION TO AWARD GRANTS ON A COMPETITIVE BASIS IN THE FIRST CALL FOR ACTIVITIES AIMED AT PROMOTING CATALAN AND ARANESE LITERATURE ABROAD

Ref. 02/L0124 U10 RES DEFINITIVA (1a C)

RECITALS

- 1. Resolution of the director of Consorci de l'Institut Ramon Llull (hereinafter Institut Ramon Llull), dated 8 February 2022 (DOGC number 8606, of 15 February 2022) opened the first call to award grants, on a competitive basis, for activities aimed at promoting Catalan and Aranese literature abroad (ref. BDNS 609826).
- 2. Resolution of the director of Consorci de l'Institut Ramon Llull, dated 16 June 2022 (DOGC number 8694, of 22 June 2022) modified the budget earmarked for the first call to award grants, on a competitive basis, for activities aimed at promoting Catalan and Aranese literature abroad (ref. BDNS 609826).
- 3. The applications submitted by the deadline established in the call are listed in the file.
- 4. On 31 May 2022, the assessment committee met to analyse and assess the applications submitted.
- 4. On 8 July 2022, the examining body issued a provisional resolution proposal for the awarding of grants, based on the recommendations of the assessment committee.
- 5. On 25 July 2022, the examining body formulates the definitive resolution proposal for the awarding of grants, in accordance with the proposal of the evaluation commission.

Legal basis

- 1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).
- 2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia
- 3. Agreement GOV/85/2016 of 28 June, which approves the modification of the type of regulatory rules approved by the Agreement GOV/110/2014 of 22 July, by which the types of regulatory rules of the procedures for the granting of subsidies under competitive competition, processed by the Administration of the Catalan Government and its public sector, are approved.



- 4. Resolution dated 1 February 2022 (DOGC number 8600, of 7 February 2022) announcing the agreement of the Board of Directors dated 19 January 2022, modifying the guidelines governing the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad.
- 5. Section 10 of the guidelines governing the call for grants awarded by Institut Ramon Llull for activities aimed at promoting Catalan and Aranese literature abroad governs the process for awarding grants.
- 6. Point 10.1 establishes that grants are awarded according to competitive tendering procedure.
- 7. Point 10.3 establishes that applications are examined by an assessment committee appointed as part of the grant call process, which will include external experts.
- 8. Point 13.1 establishes that the individual serving as Director of Institut Ramon Llull shall issue a resolution within six months of the date of the grant call.
- 9. Section 1.2 of the guidelines establishes that the grants awarded in accordance with these guidelines are considered de minimis aid, governed by Commission Regulation (EU) 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (OJ L352, 24.12.2013).
- 10. Point 13.2 establishes that the resolution will expressly state that the award is a de minimis grant.
- 11. Institut Ramon Llull has earmarked funds in this year's budget to cover the grants awarded herein.

Article 13.2.e) of the Institut Ramon Llull bylaws grants Institut Ramon Llull Management the power to award grants.

Resolution

Now, therefore, be it resolved that:

- 1. Grants be awarded for the purpose and amount to the entities listed in the Annex.
- 2. Payment of the grant shall be made in the form of an advance for 50% of the total granted, paid out upon the awarding of the grant.
- 3. The Intitut Ramon Llull initiates the processing of the payment of 100% of the amount granted once the subsidized activity has been carried out and with the prior presentation of the supporting documentation established in base 16.



- 4. These grants shall be considered de minimis grants, governed by Commission Regulation (EU) 1407/2013, of 18 December 2013, on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (OJEU L352/1, of 24.12.2013).
- 5. The recipients of the grants must undertake to provide any information requested regarding the grant awarded, at all times, and submit to any reviews or monitoring that Institut Ramon Llull or other competent bodies deem necessary.

Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, may be appealed and any such appeals must be lodged with the President of the Institut Ramon Llull Board of Directors within one month of the day following notification of this resolution. The one-month term ends on the same date the resolution was published.
