

RESOLUTION TO AWARD GRANTS ON A COMPETITIVE BASIS IN THE SECOND CALL FOR ACTIVITIES AIMED AT PROMOTING CATALAN AND ARANESE LITERATURE ABROAD

Ref. 02/L0124 U10_RES_DEFINITIVA (2a C)

RECITALS

- 1. By resolution of the director of Consorci de l'Institut Ramon Llull (hereinafter Institut Ramon Llull), dated 7 June 2022 (DOGC number 8688, of 14 June 2022) the second call was opened to award grants, on a competitive basis, for activities aimed at promoting Catalan and Aranese literature abroad (ref. BDNS 632116).
- 2. The applications submitted by the deadline established in the call are listed in the file.
- On 10 November 2022, the assessment committee met to analyse and assess the applications submitted.
- 4. On 2 December 2022, the examining body issued a provisional resolution proposal for the awarding of grants, based on the recommendations of the assessment committee.
- 5. On 21 December 2022, the examining body formulates the definitive resolution proposal for the awarding of grants, in accordance with the proposal of the evaluation commission.

Legal basis

- 1. Law 38/2003, of 17 November (General Subsidies Act), and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November (General Subsidies Act).
- 2. Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia
- 3. Agreement GOV/85/2016 of 28 June, which approves the modification of the type of regulatory rules approved by the Agreement GOV/110/2014 of 22 July, by which the types of regulatory rules of the procedures for the granting of subsidies under competitive competition, processed by the Administration of the Catalan Government and its public sector, are approved.
- 4. Resolution dated 1 February 2022 (DOGC number 8600, of 7 February 2022) announcing the agreement of the Board of Directors dated 19 January 2022, modifying the guidelines governing the awarding of grants for activities aimed at promoting Catalan and Aranese literature abroad.
- 5. Section 10 of the guidelines governing the call for grants awarded by Institut Ramon Llull for activities aimed at promoting Catalan and Aranese literature abroad governs the process for awarding grants.



- 6. Point 10.1 establishes that grants are awarded according to competitive tendering procedure.
- 7. Point 10.3 establishes that applications are examined by an assessment committee appointed as part of the grant call process, which will include external experts.
- 8. Point 13.1 establishes that the individual serving as Director of Institut Ramon Llull shall issue a resolution within six months of the date of the grant call.
- 9. Section 1.2 of the guidelines establishes that the grants awarded in accordance with these guidelines are considered de minimis aid, governed by Commission Regulation (EU) 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (OJ L352, 24.12.2013).
- 10. Point 13.2 establishes that the resolution will expressly state that the award is a de minimis grant.
- 11. Institut Ramon Llull has earmarked funds in this year's budget to cover the grants awarded herein.

Article 13.2.e) of the Institut Ramon Llull bylaws grants Institut Ramon Llull Management the power to award grants.

Resolution

Now, therefore, be it resolved that:

- 1. Grants be awarded for the purpose and amount to the entities listed in the Annex.
- 2. Payment of the grant shall be made in the form of an advance for 50% of the total granted, paid out upon the awarding of the grant.
- 3. The Intitut Ramon Llull initiates the processing of the payment of 100% of the amount granted once the subsidized activity has been carried out and with the prior presentation of the supporting documentation established in base 16.
- 4. These grants shall be considered de minimis grants, governed by Commission Regulation (EU) 1407/2013, of 18 December 2013, on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (OJEU L352/1, of 24.12.2013).
- 5. The recipients of the grants must undertake to provide any information requested regarding the grant awarded, at all times, and submit to any reviews or monitoring that Institut Ramon Llull or other competent bodies deem necessary.





Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, may be appealed and any such appeals must be lodged with the President of the Institut Ramon Llull Board of Directors within one month of the day following notification of this resolution. The one-month term ends on the same date the resolution was published.

campaign that would be used on social media, creating a promotional video, an advertising campaign in print media (*Newsweek*) and various actions at bookshops, as well as webinars (points: 8).

The committee rated the professional record of the applicant, Wydawnictwo Widnokrag S.C., a Polish publisher that specialises in literature for children and young adults (points: 8).

The committee rated positively the potential impact of the event on international dissemination of Catalan literature (points: 8).



The committee rated very positively the catalogue and professional record of the applicant, with a



prestigious catalogue specialising in international literature that includes its journal *Hyperion: On the Future of Aesthetics*, published every two years with essays, translations, interviews and reviews. *Hyperion* focuses on aesthetics, the value of art and the ways it can be transformed and renewed. Its catalogue includes texts of applied critique: philosophical essays assessing specific artists and works of art from each genre (from poetry to visual arts to cinema) (points: 8).

The committee rated very favourably the co-funding for the activity (points: 8).

The committee rated the overall interest of the proposal positively, given the importance of the English language in boosting future translations of works by the authors included in the monograph (points: 9).

The committee rated positively the potential impact of the journal in the international arena and recognises its prestige (points: 9), and rated very positively the potential impact of the event on international dissemination of Catalan literature, given the organisation's cultural influence (points: 9).

The committee proposes that the grant fund part of the expenditures derived from translating the texts, fees for collaborators, print and image rights, expenses for layout, printing and designing the journal.

The committee rated the dissemination potential of the proposal very positively, given the importance of the English language in boosting future translations of works by the authors included in the monograph (points: 8).

The committee rated positively the potential impact of the event on international dissemination of Catalan literature and considers it a strategic promotional project under the framework of the Spotlight on Catalan Culture programme organised for the London Book Fair in April 2022 (points: 9).

The committee proposes that the grant fund part of the fees for the authors and translators, production, editing and marketing expenses, and the rights to print the texts and images.

The publication of *La muerte y la primavera* has a preface by Mariana Enríquez (points: 9).

The committee rated the professional record of the applicant, Club Editor 1959, S.L., a prestigious independent publisher whose collection of translated works, La Montaña Pelada, already includes works by authors of Catalan literature like Guillem Frontera, Blai Bonet and Mercè Rodoreda (points: 9).

The committee rated the potential impact of the event on international dissemination of Catalan literature (points: 9).

The committee rated the internal funding for the activity (points: 4).

The committee also rated favourably its capacity to raise awareness of the promotion and press campaign among the local audience and highlights the publication of reviews in Argentinian newspapers like *La Nación*, *La Prensa* and the \tilde{N} supplement in *Clarín*, the preface written by Mariana Enríquez was published in the digital magazine *Página 12* (points: 13).

The committee proposes that the grant fund fees for the external press and communication firm, as well as the fees for the preface by Mariana Enríquez.

This year, 13 new authors of Catalan literature will be added: Pol Beckmann, Ana Campillo, Marta Carnicero, Josep Maria Esquirol, Marc Fernández Gómez, María González, Virginia Pedrero, Montse Maestre, Isaac Palmiola, Albert Pijoan, Ricard Ruiz Garzón, Montse Sanjuan Oriol, Care Santos and Eli Sanz (points: 7).

The committee rated the limited internal funding for the activity (points: 4).

The committee rated favourably the overall interest of the proposal as the publication seeks to publish a wide variety of Catalan authors in the journal. 
