

# DECISION ON THE NON-ADMISSION OF APPLICATIONS FOR GRANTS FOR THE PUBLICATION ABROAD OF ILLUSTRATED WORKS

Ref. 02/ L0125 U10 OBRES IL-LUSTRADES\_INADM\_DEST\_1aC

# **Background facts**

- 1. By decision of the Director of the Consortium of the Institut Ramon Llull (hereinafter, the "Institut Ramon Llull") of 25 January 2024 (DOGC –[Official Journal of the Government of Catalonia *Diari Oficial de la Generalitat de Catalunya*] no. 9092 of 1 February 2024), the first call for applications for the awarding of grants, on a competitive basis, for the publication abroad of illustrated works (ref. BDNS 741573) was opened.
- 2. By decision of the Director of the Institut Ramon Llull of 6 June 2024 (DOGC no. 9184, of 14 June 2024) the budget allocation for the first call for applications for the awarding of grants, on a competitive basis, for the publication abroad of illustrated works (ref. BDNS 704217) is hereby amended.
- 3. Applications submitted by the deadline established in the aforementioned call for applications are included in the dossier.
- 4. On 21 May 2024, the assessment committee met to analyse and assess the applications submitted.

### Legal bases

- 1. Law 38/2003, of 17 November, on general provisions for grants and subsidies, and Royal Decree 887/2006, of 21 July, approving the Regulation of Law 38/2003, of 17 November, on general provisions for grants and subsidies.
- 2. Legislative Decree 3/2002 of 24 December, approving the Consolidated Text of the Catalan Public Finance Act.
- 3. Agreement GOV/85/2016, of 28 June, approving the amendment of the standard template for governing terms and conditions approved by Agreement GOV/110/2014, of 22 July, approving the standard template for terms and conditions governing procedures for the awarding of grants, on a competitive basis, processed by the Administration of the Government of Catalonia and its public sector, and approving the full text.
- 4. The decision dated 9 January 2023 (DOGC no. 8832, of 13 January 2023), publicising the Agreement of the Board of Directors dated 15 December 2022, amending the terms and conditions governing the awarding of grants for the publication of illustrated works abroad.
- 5. Articles 21, 94.1 and 94.4 of Law 39/2015, of 1 October, on the common administrative procedure for public administrations.
- 6. Clause 12, which governs the awarding of grants from the Institut Ramon Llull for the publication abroad of illustrated works, governs the non-admission and abandonment of applications.
- 7. Clause 12.3 of the terms and conditions governing the call for applications establishes that it is the responsibility of the examining body to resolve upon the abandonment of applications submitted.



# **DECISION**

I therefore decide:

- Not to admit the grant applications set forth in the Annex hereto.

# Available appeals

Pursuant to Articles 121 and 122 of Law 39/2015, of 1 October, on the common administrative procedure of public administrations, and to Article 19 of the Institut Ramon Llull's Statutes, an appeal against this decision, which does not exhaust administrative channels, may be lodged with the Director of the Institut Ramon Llull, within one month of the day following the day on which this decision is published. The one-month period ends on the same day as the day on which the publication took place.

The committee proposes to not to admit the application submitted by the publisher Mamania Grupa Wydawnicza Relacja for the publication in Polish of *Esto no es una selva*, *Una lata en el bosque* and ¿Y si me como una ballena?, written by Susanna Isern and illustrated by Rocio Bonilla, on the grounds that it does not comply with Clause 6 of the terms and conditions governing the awarding of grants for the publication abroad of illustrated works.

Clause 6.1 states that more than one application may be submitted per publisher and per call. If the applicant applies for a grant for a series, this shall be deemed a single application. In this case, the works *Esto no es una selva*, *Una lata en el bosque* and ¿Y si me como una ballena? are not part of a series and therefore one application per work, rather than a single application for all three works, must be submitted.

The committee proposes not to admit the application submitted by Metaichmio Publications SA. for the publication in Greek of the work *Unicornia 3: Un reto mágico*, written by Ana Punset and illustrated by Diana Vicedo, as it does not comply with Clause 1 of the terms and conditions governing the awarding of grants for the publication abroad of illustrated works.

Clause 1.1 states that the illustrator of the work must be a person domiciled in Catalonia or the Balearic Islands. In this case, the illustrator Diana Vicedo is domiciled in Valencia.
