

RESOLUTION FOR THE REJECTION AND WITHDRAWAL OF APPLICATIONS FOR GRANTS TO SUPPORT INTERNATIONAL PROMOTION ACTIVITIES FOR CATALAN AND ARANESE LITERATURE CORRESPONDING TO THE 2020 CALL FOR PROPOSALS

BACKGROUND

- 1. By virtue of the resolution issued by the Institut Ramon Llull Consortium Director (hereinafter, Institut Ramon Llull) on 9 January 2020 (OGGC no. 8047 of 22 January 2020) and the amendment made to it on 10 July 2020 (OGGC no. 8179 of 17 July 2020), for the awarding of grants, on the basis of competitive tendering, to support international promotion activities for Catalan and Aranese literature.
- 2. The applications submitted in the established period for the call for proposals in question are included in the file.
- 3. On 12 November 2020, the evaluation committee met to analyse and evaluate the applications submitted.

LEGAL GROUNDS

- 1. Law 38/2003 of 17 November on grants and Royal Decree 887/2006 of 21 July approving the Regulations of Law 38/2003 of 17 November on grants.
- 2. Legislative Decree 3/2002 of 24 December approving the Revised Text of the Law on Public Finance in Catalonia.
- 3. Government Agreement GOV/85/2016, of 28 June, approving the modification of the model regulatory guidelines approved by Agreement GOV/110/2014, of 22 July, approving the model regulatory guidelines of procedures to award grants on the basis of competitive tendering, processed by the Administration of the Government of Catalonia and its public sector, and approving its whole text.
- 4. Articles 21, 93, 94.1 and 94.4 of Law 39/2015 of 1 October, on common administrative procedure for public administrations.
- 5. Point 12 of the guidelines governing IRL calls for proposals for grants to support international promotion activities for Catalan and Aranese Literature regulates the rejection and withdrawal of applications.

In accordance with the evaluation committee's report and point 12.3 of the guidelines governing the call for proposals, which states that it is the awarding body's responsibility to issue resolutions regarding the rejection and withdrawals of applications submitted,



I hereby resolve

- 1. To reject the grant applications detailed in appendix 1.
- 2. To accept the withdrawal of the grant applications detailed in appendix 2 and declare the proceedings closed.

APPEALS PROCEDURE

This decision, which is not the final administrative instance, in accordance with articles 121 and 122 of Law 39/2015 of 1 October on the common administrative procedure for public administrations, and with article 19 of the Statutes of the Institut Ramon Llull, establishes that appeals can be submitted to the Institut Ramon Llull Director, within a period of one month starting one day after this decision has been published. This month period shall end on the day bearing the same number as the day on which the publication is issued.
